# OPENING OF PRIVATE EDUCATIONAL INSTITUTIONS WITH 100% ATTENDANCE.

In pursuance to decisions taken in the meeting at National Command and Operation Center (NCOC) on 07-10-2021, all private educational institutions in Islamabad shall continue with 100% attendance with effect from 11-10-2021 with following conditions;

- i. Strict compliance of COVID SOPs including wearing of mask, social distance and others
- ii. Vaccination is mandatory for all students of age 12-18, to protect against COVID-19 and provide safety as well as improved immunity. For age group of 12-18 years, Pfizer Vaccine shall be administered (through Mobile Vaccination Teams (MVTs) in schools or at nearby COVID vaccination center).
- iii. There will be no change in cutoff dates for students' vaccination i.e. partial vaccination by 31-10-2021 and full vaccination by 30-11-2021.
- iv. The staff without vaccination shall not be allowed to enter school/college.
- v. Management/Head of Institution is responsible to submit certificate regarding vaccination of 100% staff and students of age group 12 and above.
- vi. Teams of District Administration may visit randomly to check the status of staff vaccination and for necessary action accordingly.
- 2. It is reiterated that vaccination of students (age 12 and above) and left over staff is mandatory for all educational institutions. No institution is exempted from subject matter.

3. All Private Educational Institutions are directed to ensure compliance of government policy in true letter and spirit.
